PRELIMINARY REPORT ON THE OUTCOME OF THE PUBLIC PARTICIPATION FORUM ON THE PROPOSED NAIROBI CITY COUNTY ANIMAL CONTROL AND WELFARE BILL OF 2024.

The Nairobi City County Government proposes to have in place an Animal Control and Welfare Bill with the intention to put in place guidelines for welfare and control of animals within Nairobi City County and in so doing protect residents from physical, medical, psychological and environmental harm as they relate with animals.

In addition, animals' welfare will also be protected by measurers in this Bill from harm posed by human activities and lifestyles within the County cognizant of the high population density in the City.

Pursuant to Article 10 of the Constitution of Kenya, 2010, Section 115 (1) of the County Government Act 2012 and Section 6 (a) iv of the Nairobi City County Public Participation Act 2016, that provides for Public involvement and engagement in making decisions affecting them, the County Executive organized a public participation forum on the proposed Animal Control and Welfare Bill 2024. It invited interested members of the public and interested stakeholders to the public participation forum which was held on Friday, **2nd of August 2024** at Charter hall from **noon till 3PM**.

This initial feedback to participants and residents of County should help citizens to follow through with the proposal.

The County government admits from the peaceful and candid engagements held during the public participation forum, that there is need to start afresh since there was inadequate stakeholders' engagement at the configuration of the initial draft. A notice shall be issued to invite all stakeholders for a meeting to redraft the Bill that will give preference to animal welfare including management and control of the same as stated in our constitution. The County Government and stakeholders will deliberate on all non-contentious issues in the bill to seek concurrence and consensus with the existing national and international legislations.
