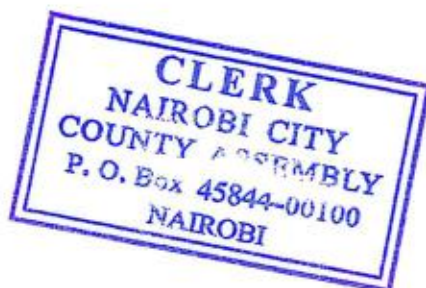

**THE NAIROBI CITY COUNTY APPROPRIATION
ACT, 2014**

No. 6 of 2014

Date of Assent: 30th June, 2014

Date of Commencement: 1st July, 2014

AN ACT of Nairobi City County Assembly to authorize the issue of a sum of money out of the County Revenue Fund and its application towards the service of the year ending on the 30th June, 2015 and to appropriate that sum and a sum voted on account by the Nairobi City County Assembly for certain public services and purposes

ENACTED by the Nairobi City County Assembly as follows—

1. This Act may be cited as the Nairobi City County Appropriation Act, 2014. Short title.

2. (1) The County Treasury may issue out of the County Revenue Fund and apply towards the supply granted for the service of the year ending on the 30th June, 2015, the sum of Kenya Shillings 28,762,590,000 (twenty eight Billion, Seven Hundred Sixty Two Million, Five Hundred and Ninety Thousand) and that sum shall be deemed to have been appropriated as from 1st July, 2014, for the services and purposes specified in the Schedule annexed hereto. Issue of KSh. 28,762,590,000 out of the County Revenue Fund for public services and purposes of the year ending 30th June, 2015 and appropriation of the money granted.

(2) The sum granted out of the County Revenue Fund by subsection (1) as authorized by the Nairobi City County Assembly on the 19th June, 2014, in accordance with Article 224 of the Constitution.
